1. APPROVAL OF MINUTES

Vice Chairman Lori Buehlman directed the meeting. Todd Robertson made a motion to approve the minutes and Steve Schaefer seconded the motion; motion carried.

2. OLD BUSINESS

A. Project Update – presented by Pam Drach

CITY OF EVANSVILLE

<u>Covert Avenue Road Diet:</u> The consultant is working on Stage 1 plan design.

<u>Weinbach Avenue Road Diet:</u> Stage 1 design plans and corresponding documentation is complete and has been submitted to the City. The environmental notices have been sent.

<u>SR 66/Lloyd Expressway Pedestrian Overpass:</u> Excavation of the MSE wall leveling pads is complete and the contractor will begin pouring the pads. MSE wall construction will begin once the leveling pads are completed.

<u>Pigeon Creek Greenway Passage Project (Arts-Glenwood-Hi-Rail Corridors):</u> The corridor has been divided into 2 phases: the Hi-Rail Corridor and the Downtown Connector. The Lochmueller Group has been selected to complete the design for the Hi-Rail Corridor, and the Notice to Proceed was given on June 19, 2015.

<u>Tekoppel Safe Routes to School:</u> Construction is approximately 45% complete.

VANDERBURGH COUNTY

<u>Burkhardt Road/Virginia Street:</u> Phase 2 of construction is underway with work being done east of Burkhard Rd. and north of Virginia St. on the west side of Burkhardt Rd.

<u>Green River Rd Widening, Millersburg Rd to Kansas Rd:</u> The project is 94% complete and is expected to be finished by the end of July.

Maryland Street Bridge over Pigeon Creek: Work on the west end of the bridge is continuing.

<u>Heckel Road Widening, Green River Rd to Oak Hill Rd:</u> Appraisals are underway and offers are being made to property owners.

TOWN OF NEWBURGH

Newburgh Rivertown Trail: Pavement design has been approved.

<u>Newburgh Sign Replacement:</u> Information collected by TransMap, including retroreflectivity data, has been forwarded to Newburgh and the Town continues contract negotiations with the consultant.

WARRICK COUNTY

<u>Lincoln Avenue:</u> The environmental AI (Additional Information) document has been approved and the right-of-way activities are underway.

<u>Oak Grove Road – Phase 2:</u> Pavement design has been approved. All parcels have been acquired. Ready for Contracts documents have been submitted in INDOT. The project is scheduled for a September 2, 2015 letting.

<u>Oak Grove Road – Phase 3:</u> The supplemental for R/W Engineering and Final Design has been approved, and the consultant is working to schedule a public information meeting later this summer.

INDOT

<u>US Highway 41/Lloyd Expressway Interchange:</u> Construction is continuing on the SE loop, connector and the pedestrian bridge and path. Project is still on target to be substantially complete by September 15, 2015.

<u>US Highway 41, Boonville-New Harmony Road to SR 168:</u> Due to weather delays, the completion date has been revised to late September of 2015. The SR 68 intersection is under construction.

Kevin McClearn gave an update on I-69 in Kentucky. A contract has been let to re-sign the Pennyrile Parkway as I-69, and several of these signs are located within the Henderson city area. The completion date should be this fall. The goal is to sign the Pennyrile Parkway as I-69 this year south of the KY 425 interchange. Five projects are currently underway in the District 2 area for these sign replacements, and they should be completed this fall as well. An agreement has been made with Federal Highway to officially designate that corridor as I-69 by the end of the year.

3. NEW BUSINESS

A. Transportation Alternatives Program Project Application – Warrick Trails

Erin Schriefer presented the Transportation Alternatives Program (TAP) application that the MPO received from the Warrick County School Corporation and Warrick County Commissioners. TAP funds in the amount of \$964,328.00 were requested to construct approximately 1.25 miles of biking and walking trails. The proposed trails would connect neighborhoods and schools while enhancing the safety of the students and nearby residents. A connection between Castle High School, Castle North Middle School, Castle South Middle School, and John H. Castle Elementary School would be established via the proposed trail and its connections to the existing sidewalk along SR 261.

It was noted that an approximately 0.25 mile-long segment (on Casey Road from Vann Road to the Castle South Middle School entrance) is located outside of the MPO Urban Area Boundary, but because of the integral connection it provides to the overall network, is eligible for TAP funds.

Lori Buehlman, on behalf of the Newburgh Town Council, presented a letter of support for this trail project.

Steve Melcher made a motion to approve the TAP application and requested funding and Buzzy Newman seconded; motion carried.

B. FY 2013-2016 & FY 2016-2019 TIP Amendments – presented by Pam Drach

<u>Des# 1400209:</u> Various Location along I-64, SR 161, SR 62, SR 66, US 41 – Culvert clean and repair. Add project for Preliminary Engineering FY 2016. PE costs of \$150,000 will be funded with 80% federal

NHS funds and 20% State match. Add project for Construction in FY 2018. CN costs of \$807,000 will be funded with 80% federal NHS funds and 20% State match.

<u>Des# 1500728:</u> SR 161 over Otter Creek, 1.36 miles S of SR 62 – Bridge Deck Overlay, Small Structure Pipe Lining (Includes Des# 1500714 and 1500693). Add project for Preliminary Engineering in FY 2016. PE costs of \$271,000 will be funded with 80% federal NHS funds and 20% State match. Add project for Construction in FY 2018. CN costs of \$984,000 will be funded with 80% federal NHS funds and 20% State match.

<u>Des# 1500712:</u> SR 62, 5.99 miles W of US 41 – Small Structure Pipe Lining. Add project for Preliminary Engineering in FY 2016. PE costs of \$47,100 will be funded with 80% federal NHS funds and 20% State match. Add project for Construction in FY 2018. CN costs of \$170,000 will be funded with 80% federal NHS funds and 20% State match.

<u>Des# 1592150</u>: SR 62, from E end of Pigeon Creek bridge to 300ft W of 1st Ave Bridge (Segment 1) Environmental Mitigation. Add project for Preliminary Engineering in FY 2016. PE costs of \$67,000 will be funded with 80% federal NHS funds and 20% State match.

Steve Melcher made a motion to approve the TIP Amendments and Todd Robertson seconded; motion carried.

4. OTHER BUSINESS

A. Subdivision

Laura Lamb presented The Stables South (6-S-2015) in Vanderburgh County on the east side of Green River Rd, south of Pollack Ave. The MPO has recommended to the Area Plan Commission that sidewalks be installed and connected to the existing sidewalk network on Green River Road due to the proximity of shopping, school and transit services in the area.

B. Rezoning

Laura Lamb presented a rezoning at 6635 Old Boonville Highway in the City of Evansville. The project is proposed to a condominium complex that will access through the existing private drive used by The Arbors at Eastland apartments. The MPO has recommended to the Area Plan Commission that depending on the existing traffic counts on Old Boonville Highway and the number of turns into the existing access, improvements to the right turn lane may be necessary.

Lori Buehlman reported that the Neighborhood Walmart Market rezoning in the Town of Newburgh passed at their most recent Town Council meeting.

C. Approval of Bills

Steve Melcher made a motion to approve the bills and Kevin McClearn seconded the motion; motion carried.
