### 1. APPROVAL OF MINUTES

### 2. OLD BUSINESS

#### A. Project Update- presented by Pam Drach

##### CITY OF EVANSVILLE

Washington Avenue/Weinbach Avenue Intersection: Construction is complete.

Covert Avenue Road Diet: Meeting was held with the consultant on December 15<sup>th</sup> to discuss the Stage 1 plan submittal.

Weinbach Avenue Road Diet: Stage 1 plans were submitted to the City for review, and returned to the consultant for revisions. A Preliminary Field Check is tentatively scheduled for February 2, 2016.

Washington Avenue/2<sup>nd</sup> Street – Parrett Street Area: The consultant is proceeding with submission of the historical properties documentation for review and comment.

## **VANDERBURGH COUNTY**

Maryland Street Bridge Over Pigeon Creek: The old beams on the center span will be replaced over the next month.

## **INDOT**

US Highway 41, Boonville-New Harmony Road to SR 168: Construction is complete.

## **CITY OF HENDERSON**

Sand Lane Safe Routes to School: Construction is complete.

## **3. NEW BUSINESS**

### **A. FY 2016-2019 TIP Amendments – presented by Craig Luebke**

- i. Item# 02-2091: US 41: Bridge Deck Overlay, SBL Vietnam Gold Star Bridge. Add project for Preliminary Engineering (PE) phase in FY 2016 for design costs (\$250,000) and Construction (CN) in FY 2017 (\$6,000,000). PE and CN phases will be funded by federal National High Performance Program (NHPP) funding and a match comprised of Kentucky Toll Credits.

John Petkovsek made a motion to approve the TIP Amendment and Bill Harty seconded the motion; motion carried.

Bill Harty expressed concern regarding the 5-point intersection at Tekoppel Avenue and Hogue Road on Evansville's west side.
