

#### 1. APPROVAL OF MINUTES

Shawn Hayden made a motion for approval and Matthew Bullock seconded the motion; motion carried.

#### 2. OLD BUSINESS

#### a. Project Update - presented by Pam Drach

#### **City of Evansville**

- <u>Covert Ave:</u> Asphalt paving from US 41 to Vann Ave is complete. Pavement markings are planned for installation the week after Labor Day with signal items to follow.
- Walnut St Phase 1 (US 41 to Weinbach Ave): Construction activities are complete and the corridor is open to traffic.
- Walnut St Phase 2 (Weinbach Ave to Vann Ave): One parcel remains in the condemnation process. Final Tracings packet is to be submitted October 4, 2021. Letting moved to January 12, 2022.
- Walnut St Phase 3 (MLK Jr Blvd to US 41): Final environmental document has been submitted. Preliminary field check rescheduled for mid-October to allow for additional utility coordination.
- <u>Signal Preemption:</u> Construction activities are underway (approx. 80% complete) and are expected to be complete in October 2021

Signal Modernization (Green River and Washington): Construction is approximately 90% complete.

#### **Vanderburgh County**

- <u>Franklin St Bridge:</u> A final field check was held on August 20, 2021; a levee permit was approved by the commissioners on August 17, 2021; DNR construction in a floodway permit was approved on July 28, 2021; the environmental document was approved on July 12, 2021.
- Oak Hill Rd (Eastwood Dr to Millersburg Rd): The right of way (r/w) is being evaluated on a number of parcels in order to determine if the permanent r/w limits can be reduced with a combination of permanent and temporary r/w; design work and utility coordination is continuing.
- Oak Hill Rd (Lynch Rd to St George Rd): State 1 plans were submitted to INDOT on July 22, 2021.

#### **Warrick County**

- <u>Bell Rd:</u> North of Oak Grove, utility relocation is complete and roadway construction is ongoing.
- Warrick Trails SRTS: Utility relocations are ongoing. Trail construction is underway.
- <u>Telephone Rd:</u> Utility coordination is underway.

#### City/County of Henderson

• Wathen Lane: Environmental document approval expected in mid-October.

#### **KYTC**

• Watson Lane: Tentative joint inspection meeting proposed for October.

#### **INDOT Updates – presented by Matthew Bullock, INDOT**

- (RS-39357) SR 66 from E of SR 161 to E Jct SR 161 Reo: Paving is almost complete. Should be complete in the next three weeks.
- (B-43148) US 41 Bridge over Pigeon Creek: Pavement work is ongoing. Bridge has been demolished. Piling work should begin in a few weeks.
- (B-42109) US 41 NB Ramp over Eagle Creek: Final plans due September 17, 2021.
- (R-39921) US 66 at Epworth Rd: Revised Stage 2 for dual displaced left to be submitted before end of September. Environmental work is ongoing. Public hearing is anticipated in late fall or early winter.
- (R-40551) SR 62 (various locations between SR 61 and the West Jct SR 161): Working through right of way process. Tree clearing to be done under a maintenance contract.
- (R-37845) US 41 at Hillsdale Rd: INDOT Legal and CSX Legal meeting to discuss easement terms on September 10, 2021.
- (R-41410) US 41 from N of SR 66/SR 62 (Lloyd Expwy) to N of SR 66 (Diamond Ave): Finalizing roadway profile, Traffic Management Plan stakeholder meeting scheduled for September 22, 2021.
- (B-42876) US 41 Pedestrian Walk at US 41 and Washington: Still working through the Section 106 process which is required due to the historic properties in the area. Once that is complete the NEPA document can be submitted for review and released for public involvement.
- (R-42287) SR 62 from Rosenberger Ave to Wabash Ave; US 41 over SR 66/Diamond (including various intersections improvements from Rosenberger Ave to Cross Pointe Blvd): Working through revision requests from the Stage 1 review. Determining pavement replacement options for roadway and intersection improvements. Started development on west side intersections. Traffic Management Plan stakeholder meeting is anticipated in mid-October.

Nate Hahn asked if the work that is being done right now at the intersection of US 41 and SR 57 is part of contract R-37845. Matthew Bullock explained that work is separate from the projects listed here. It is being done as an emergency project to deal with the rutting on the northbound side of the roadway and should be finished pretty quickly.

This item was informational and did not require a committee action.

#### b. TIP Modifications – presented by Pam Drach

The City of Evansville requested the following modification on July 26, 2021:

<u>Des# 1802795</u>: Signal visibility improvements: Replace 8" signal heads with 12" signal heads in the Evansville signal system. Move the construction from FY 2021 to FY 2022.

The Indiana Department of Transportation (INDOT) requested the following emergency amendment on July 29, 2021:

<u>Des# 2100287:</u> Safety Revisions: Development of the Statewide Highway/Rail Grade Crossing Safety Action Plan. Add Preliminary Engineering (PE) in FY 2022 at a total cost of \$100,000. Costs will be funded with 90% Federal HSIP and a 10% state match.

<u>Des# 1802074:</u> Oak Hill Rd from Eastwood Dr to Millersburg Rd: Add Right of Way (RW) in FY 2022 for a total of \$750,000 using 100% local funding.

#### The Indiana Department of Transportation (INDOT) requested the following modification on August 26, 2021:

<u>Des# 1902031:</u> Various locations in the Vincennes District (Contract T-42464): Curve sign and marking visibility improvements project. Increase Construction (CN) funding from \$750,000 to \$1,337,000 and move CN from FY 2022 to FY 2023. Costs will be funded with 90% Federal HSIP and a 10% state match.

# The Evansville Metropolitan Planning Organization processed the following administrative modifications to the FY 2022-2026 TIP on September 2, 2021:

<u>ID# 02-382:</u> Wathen Lane form US 60 to the City limits: Add the right of way and utility phases previously listed for FY 2021 obligation to FY 2022. The phases will be funded with a combination of Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) funding, Federal SHN funds and local match.

ID# 02-321: Green River Rd from Bend Gate Rd to Osage Dr: Move Construction (CN) from FY 2022 to FY 2023. The phase will be funded with Federal TE/TAP funds and local match.

This item was informational and did not require a committee action.

#### c. Call for Projects Amendment – presented by Pam Drach

Based on feedback from the City and County engineers and following an internal review, it is recommended that the construction inspection policy presented in the project call be revised as follows:

*It is advised that neither* Consultants nor subconsultants who prepare engineering construction plans or construction contract bid documents for a project programmed for EMPO Construction Engineering/Inspection funding shall be associated with construction inspection activities for plans or bid documents they prepared.

Shawn Hayden made a motion for approval and Lorie Van Hook seconded the motion; motion carried.

(Jeff Whitaker, Lochmueller Group, abstained from voting due to Lochmueller Group providing both of these services.)

#### d. Kentucky SHIFT Regional Boost Project Selection – presented by Laura Lamb

One of the final steps in the SHIFT Kentucky Ahead statewide prioritization process for roadway projects is the selection of "Boost" projects. All of the projects listed below were "sponsored" either by the EMPO, in coordination with the City of Henderson and Henderson County, or the KYTC District 2 from the CHAF (Continuous Highway Analysis Framework) database of currently unfunded projects. The EMPO is allotted three Boost Projects which will each receive an additional 15 points added to the KYTC Quantitative Score to increase the potential ranking going into the statewide selection of projects vying for funding by the Kentucky Legislature. The EMPO has selected the three highlighted projects below. Public comment will be accepted on the proposed selection starting September 2<sup>nd</sup> and continuing through the EMPO public meetings scheduled on September 9<sup>th</sup>.



The FAST Act and subsequent federal rulemaking established five performance measures related to safety. The measures are:

- Number of fatalities;
- Rate of fatalities per 100 million vehicle miles traveled;
- Number of serious injuries;
- Rate of serious injuries per 100 million vehicle miles traveled; and
- Number of non-motorized fatalities and serious injuries.

Federal regulations require state DOTs to establish and report annual targets to each of these five performance measures by August 31<sup>st</sup> of each year. MPOs are required to either adopt and support their DOT's statewide targets or set their own targets specific to their areas within 180 days of that date. At this time, the EMPO is recommending the adoption and support of the statewide targets for both INDOT and KYTC.

The mission of the Kentucky Transportation Cabinet (KYTC) is to provide Kentuckians and travelers with a safe, efficient, environmentally sound and fiscally responsible transportation system. Our transportation network extends beyond bridges and highways and must meet the needs of the Commonwealth's diverse and growing population.

KYTC's Long-Range Statewide Transportation Plan (LRSTP) is a planning document that identifies the goals, policies, needs, and analysis tools that set the direction of Kentucky's transportation system toward 2045. Transportation keeps us connected to what matters most. Everyone has a role to play in the planning process to help shape the state's long-term, multi-modal transportation vision that will build a better Kentucky now and well into the future.

The LRSTP update is an important opportunity for all Kentuckians to weigh in on the state's long-term multimodal transportation vision and help adapt to changing needs that impact our transportation system.

## **Building the Plan**

Updating the LRSTP is an 18-month process that began in the late summer of 2021 and will end by December 2022. KYTC transportation leaders and consultants from Michael Baker International are spearheading the effort to develop a comprehensive plan.

As we set the course for the future of Kentucky's transportation system, we're giving everyone a voice in the planning process. We will offer several opportunities to hear public and stakeholder input throughout the planning process to help shape the direction of statewide transportation planning for the next 25 years.
