#### 2. APPROVAL OF MINUTES

Mayor Lloyd Winnecke made a motion for approval and Jill Hahn seconded the motion; motion carried.

#### 3. OLD BUSINESS

#### a. Project Update - presented by Pam Drach

#### City of Evansville

- Walnut St Phase 2 (Weinbach Ave to Vann Ave): From Weinbach to Boeke, the roadway has been restored to the intermediate course. Construction of the multi-use path continues. Traffic is allowed in from Boeke and several north-south side sideroads have been opened to accommodate residential traffic. From Boeke to Vann, staggered barricades have been placed to reduce through traffic movements. Waterline extension will begin soon along the corridor.
- Walnut St Phase 3 (MLK Jr Blvd to US 41): Right of way acquisition is complete and the project is ready for letting.

#### **Vanderburgh County**

- Franklin St Bridge (over Pigeon Creek): Construction was completed in December 2022.
- Oak Hill Rd (Eastwood Dr to Millersburg Rd): Right of way activities are continuing with 37 of 48 parcels secured. Permit applications have been submitted.
- Oak Hill Rd (Lynch Rd to St George Rd): Field work for wetland delineation and archeology sampling is complete. Right of way engineering is underway. Consultant is working on Stage 2 plans and utility coordination.
- Epworth Rd (SR 662 to SR 66): Survey activities underway. A kick-off meeting was held on October 11, 2022.

#### City/County of Henderson

• Wathen Lane (US 60 to city limits): All parcels have been secured. The Consultant is working on final plans for letting.

#### **KYTC**

- Watson Lane (Sunset Ln to Green River Rd): Appraisal activities are under contract and 19 appraisals are expected to be completed in March.
- <u>US 60 Spottsville Bridge:</u> All construction activities are complete.

## <u>INDOT Updates – presented by Rusty Fowler</u>

- (B-43148) US 41 Bridge over Pigeon Creek: Bridge deck is poured. Working on SB pavement.
- (B-44156) US 41 over SR 66/Diamond Ave: Project is posted on the January 19<sup>th</sup> letting; have received several contractor questions.
- (R-39921) US 66 at Epworth Rd: Project files sent to central office to be advertised for the February 10, 2023 letting.
- (B-42876) US 41 Pedestrian Walk at Washington Ave: Environmental complete. RW is in buying and working through getting utility relocations started.
- (R-37845) US 41 at Hillsdale Rd: Project bundled, awaiting fees from Burgess & Niple to complete design of the structures. Working on Shared Use Agreement with CSX.
- (R-42287) SR 62 Road construction and intersection improvements along the Lloyd Expressway: Working on Stage 2 design. Also working on environmental and utility coordination. RW Engineering complete and starting the acquisition process.

#### **4. NEW BUSINESS**

## a. Draft MTP 2050 Update and Conformity Determination - presented by Pam Drach and Erin Schriefer

Pam Drach provided a high-level overview of the Metropolitan Transportation Plan, the Transportation Improvement Program, and the associated air quality conformity determination and how they all work together. The Transportation Improvement Program (TIP) is a 5-year program of projects with financial commitment for the project development & construction. When a government agency is ready to move forward with financial commitment to a project under their jurisdiction, they would select a project from the MTP or another planning document, such as safety, asset management, bicycle and pedestrian, or local capital improvement plan, and submit the project as part of the Call for Projects process. Once selected during the call, the project would then be programmed into the TIP.

The Metropolitan Transportation Plan (MTP) 2050 contains a list of identified needs proposed for funding within the 20-plus year timeframe of the plan. The needs have been identified through the planning process which includes, but is not limited to data analysis, modeling, coordination with State and local stakeholders, and input from advisory groups.

The projects included in the plan must be fiscally constrained. Only those projects that can be supported by a fiscal plan based on identified funding that is reasonably expected to be available for the 20-year time frame can be included in the plan. It is not until the project is placed in the TIP with a funding commitment made that the specific years for development and construction are set.

Timeframes used in the MTP correspond with the air quality conformity process. A conformity determination for the MTP and TIP is required, however, modeling itself is not a requirement at this time.

Exempt vs Non-Exempt projects are labeled in both documents. These terms are in reference to conformity regulations. Exempt projects do not need to be a part of any analysis and typically include preservation, safety and alternative mode projects. Non-exempt projects need to be included in the conformity determination and typically include capacity added projects. Prior to non-exempt projects being programmed in the TIP, the project must first be in the MTP.

Erin Schriefer provided more details on the completed draft of the Metropolitan Transportation Plan (MTP) 2050 and associated conformity determination. The purpose of this document is to guide the decision-making process related to roadways, public transportation, freight movement, and bicycle and pedestrian facilities in the region while conforming to federal standards. The MTP 2050 is a guide for regionally significant transportation projects through the year 2050 and will replace the MTP 2045 plan once adopted.

The Recommendations chapter from the MTP 2050 is included in your packets. The first three tables include the roadway projects identified as a result of the planning process. These projects are broken down into three open to traffic timeframes: 2024-2030, 2031-2040, and 2041-2050. These projects are fiscally constrained, meaning the estimated construction costs for these projects fall within the amount of federal funding the MPO is anticipated to receive through 2050. The projects included in these three tables are regionally significant. LPAs may have plans for road and bridge preservation and maintenance, intersection improvements and other projects that are considered non-regionally significant, but these project types are not included in the MTP.

There are ID numbers associated with each project in the MTP. These numbers do not reflect a priority of any kind - it's just a tracking number for reference to the map.

The next table in the recommendation chapter is for illustrative needs projects. These are projects that have been identified as a need but are not included in the financial constraints of the plan.

Policy level recommendations are also included in this chapter for public transportation, bicycle and pedestrian facilities, freight, safety, and a new section discussing sustainability, climate and resiliency recommendations.

A 30-day public comment period will begin on January 25<sup>th</sup> and close February 24<sup>th</sup>. We encourage Policy members to review and comment on the draft MTP 2050. If you have comments and wish for them to be addressed in the draft plan before the public comment period starts, we ask that you please provide those comments to me (my email address is in the memo) by next Friday, January 20<sup>th</sup>.

We will also be hosting public open house events in February. These meetings are currently scheduled for February 8<sup>th</sup>, but we will be sending out an email with more details tomorrow, along with a link for you to review the entire plan online. The final MTP will be presented for approval at the March Policy Committee meeting. Please reach out to us with any questions.

### d. Transportation Air Quality Conformity Protocol – presented by Pam Drach

The Evansville MPO is seeking approval of the interagency consultation group Transportation Air Quality Conformity Protocol. The protocol outlines the process for determining the conformity of the Metropolitan Transportation Plan and Transportation Improvement Program with state and federal air quality plans and procedures.

Ron Beane made a motion for approval and Todd Robertson seconded the motion; motion carried.

## Before moving to Other Business, Pam Drach and Matt Schriefer added the following information:

Pam Drach provided the draft program of projects for the 2024-2028 Transportation Improvement Program. The TIP was developed in coordination with state DOTs, LPAs, transit agencies, and non-profit organizations. The state DOT's programs have more of a preservation and safety aspect. The Evansville MPO gets approximately \$8.5 million in federal dollars for the local program for Indiana and about \$1 million for Kentucky, and transit for the urbanized area gets about \$4 million per year.

Projects in the TIP are identified during the Call for Projects process, in which LPAs submit their application and letter of funding commitment for a project. Once the project is selected, it will go into the TIP. Project update meetings are held quarterly with LPAs, consultants and INDOT to track the progress of the project and collaborate on any challenges identified to meet the project schedule and budget.

It is the policy of the Evansville MPO to fully fund construction and other construction-related activities first, and if there are any balances remaining, that money is distributed to projects that are eligible for development costs.

In this draft of projects, the I-69 ORX is not included. The ORX team is finalizing the financial plan, and once that plan is complete, the information will be used to determine how to show the project in the TIP. The ORX will be added before the draft TIP goes out for public comment. A turn lane project on Airline Road and KY 812 in Henderson may also be added to the TIP before going out for public comment.

The TIP will be going out for public comment, along with the MTP and associated conformity determination, on January 25, 2023.

Matt Schriefer announced that the Evansville MPO has also completed a draft of the 2023-2027 Coordinated Public Transit – Human Services Transportation Plan. This plan includes a list of the Section 5310 eligible projects through the FTA that are planned for implementation by either METS, HART, or area non-profits to help improve transportation access for seniors and individuals with disabilities. This updated coordinated plan will cover projects to be completed in 2023 through 2027. A draft of the coordinated plan will be sent out to the Policy Committee, Technical Committee, and the Regional Transit Advisory Committee for review and comment. The public comment period and open houses will be coordinated with the MTP and TIP comment period and open houses.
