#### 3. OLD BUSINESS

# a. Project Update - presented by Pam Drach

# **City of Evansville**

- Walnut St Phase 2 (Weinbach Ave to Vann Ave): The project is approximately 85% complete. The Vann Ave speed hump is under construction and will be open on September 8<sup>th</sup>. The Boeke Ave intersection is operating in a 4-way flashing red condition on the signal. The Weinbach Ave intersection will be closed within the month for 30-day reconstruction.
- Walnut St Phase 3 (MLK Jr Blvd to US 41): The first phase of the project is under construction from US 41 to Kentucky Ave. This will take approximately 30 to 45 days. Utility relocation is being completed along the rest of the corridor with gas relocation currently at Denby and Walnut.
- 2<sup>nd</sup> St/Parrett St/Jefferson St: Additional public meeting was held on August 16, 2023.

# **Vanderburgh County**

• Oak Hill Rd (Eastwood Dr to Millersburg Rd): Right of way activities are continuing with 45 of 48 parcels secured.

#### City/County of Henderson

• Wathen Lane: The environmental document is being updated.

#### INDOT Updates – presented by Matthew Bullock

- (B-42718) SR 66: Project complete.
- (B-44156) US 41 Small Structures and Bridge Decks: Bridge decks are complete and the small structures and drain construction is ongoing.
- (R-39921) SR 66 at Epworth Rd: Construction is ongoing.
- (R-42753) I-69: Construction is ongoing. The off ramp at Boonville New Harmony Rd is closed.
- (B-42876) US 41 Pedestrian Walk at Washington Ave: Ground breaking is scheduled for September 28, 2023.
- (B-42187) I-64 over abandoned N & S RR: Project pushed back from September 13, 2023 letting to the October 12, 2023 letting.
- (R-41410) US 41 from SR 66/SR 62 (Lloyd) to SR 66 (Diamond): Final plans sent to central office to be published on the October letting. Finalizing revisions to avoid utility conflicts.
- (R-44898) Various intersection improvements on SR 66: Final plans were sent to central office; finalizing preprint revisions. Set to be advertised on the November letting.
- (R-42287) SR 62 Lloyd4U project: Three project numbers were separated out of this contract (Wabash Ave, St Joe Ave and the pavement between Barker Ave and Wabash Ave); these three moved out to a July 2025 letting. This is to accommodate utility relocations. The rest of the projects in this contract are set to let in February; final field check held August 29, 2023; Stage 3 plans will be submitted in September; INFRA Grant Application submitted. Working on utility reimbursement agreements. Public hearing is scheduled for September 26, 2023.
- (B-42728) SR 62 bridge thin deck overlay: Final field check scheduled for September 7, 2023; questions/comments coming shortly. Environmental document is being reviewed.
- (B-42199) SR 66 from 2.76 mi west of US 41: geotechnical report was submitted on August 30, 2023.
- (T-45152) SR 62 Lloyd4U project: New contract for the three projects separated out from R-42287 to allow for utility relocations. Public hearing is scheduled for September 26, 2023.


